\*Wee Miss Tiny Tot contestants <u>must</u> have an adult accompany them on stage. They do not have to hold the contestants' hand, but they must be close enough to touch them at all times. Wee Miss contestants will walk alone but <u>will not</u> be scored on modeling.

- ✓ Age on JULY 1, 2026\* determines age division for local & state pageant. You may move up a division on the local level, but you must compete in the same division at the state pageant, you cannot move back down.
- ✓ Proof of date of birth is required for ALL state contestants.
- ✓ All contestants **must** be South Carolina residents.
- ✓ \*\* If you have already won a title that qualifies you to compete in the 2026 Little Miss South Carolina Pageant, you are not eligible to compete in this pageant.

ONLY **ONE** (1) adult will be allowed in the dressing room and rehearsal area with each contestant.

AWARDS: Beauty winners receive a crown & LMSC sash and will participate in the Little Miss & Teen Miss South Carolina Pageant in <u>JULY</u>! All contestants not placing will receive a gift. Photogenic winners will receive a small tiara. Prettiest award winners will receive a crown pin.

JUDGES WILL BE TOLD: Sunday dress or pageant dress is acceptable for ages 2-3; hair and make-up should be appropriate for child's age; look for beauty, poise, and personality on stage; modeling will NOT count for ages 6 and under and will not be the main focus for ages 7-26. Ages 4-6 and 7-9 may wear a short or long pageant dress. Ages 10 and up should wear a long dress/evening gown; hair, make-up and gown should be age appropriate.

NO PRO-AM MODELING!!!

Scores and/or score sheets will <u>NOT</u> be given – this is against the rules of the *Little Miss South Carolina Pageant*. Judges are <u>NOT</u> to be approached before, during, or after the pageant. <u>ALL</u> contestants, family, and friends are expected to display good sportsmanship – failure to do so may result in disqualification with <u>NO REFUND OF FEES!</u>

\*\* State winners ages 6 and under do not need permission to compete in other local pageants if they make their required appearance for Little Miss South Carolina. They are not allowed to compete in other state or national pageants while a LMSC STATE titleholder.

State winners ages 7 and up are not allowed to compete in other pageants during their reign, except for their school pageant. There are NO restrictions on local winners competing in other pageants. \*\*
